JPFC/0918/01 Apologies for Absence

JPFC/0918/02 Variation of Order of Business

JPFC/0918/03 Declaration of Members Interest

Councillor Bradbury declared interests in the Parish Field

JPFC/0918/04 Minutes of the of the JPFC held on 20 March 2018

Resolved: that the Minutes of the JPFC meeting held on 20 March were confirmed as a correct record under the provisions for approval and signed by the Chairman.

JPFC/0918/05 Playing Field Drainage

Councillor Bradbury updated the Committee on the works undertaken and the costs. It was noted that:

a) the invoices were presented at the meeting therefore the payment would be made once the Clerk had arranged for the fund withdrawal from the Playing Field account

b) that a resident had verbally offered to pay half of the costs and that the Clerk would check if this was the case.

c) the trench crosses a public footpath with the tarmac needing reinstating, it was
