## Definitions

1. 'relevant person' means you as a member of Derbyshire County Council or:
  - i. your spouse or civil partner
  - ii. a person with whom you are living as husband or wife or
  - iii. a person with whom you are living as if you were civil partners
2. 'body in which the relevant person has a beneficial interest' means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director or in the securities of which the relevant person has a beneficial interest.
3. 'securities' means shares, debentures, debenture stock, loan stock, bonds, unit of collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
4. 'land' excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income.
